Central Lake Village Council accepts resignation

CENTRAL LAKE - The Central Lake Village Council's issues with their new president continued Monday night, and much to the surprise of many of those in the audience, the resignation of longtime Council member and president pro-tem Brian Patton was accepted during a lengthy monthly meeting that included a number of other actions.

Objections to the new president, Walter Russell, as well as calls for his resignation, were also once again heard from several members of the large audience, which packed the Central Lake Government Center meeting room, during public comment as well as throughout the meeting.

A motion to refuse the resignation of Patton, a member of the Council for 20 years and a longtime village business owner, came midway through a meeting which included remarks from the former temporary campground

caretaker, Deb Hopp, who was not hired fulltime, the hiring of a part-time seasonal DPW employee, a decision to begin the legal process to renew a leased portion of Thurston Park, and a decision to begin the process to regulate medical marijuana as a business in the village, as well as discussion surrounding the recent suspension by Russell of the Village Clerk.

Patton had submitted a letter to Council members as well as others in late April, noting his intent to resign his position April 22 if Russell did not "step up and do the job" that Patton maintained he had been forced to deal with since Russell's election to the detriment of both his business and his personal life.

Proposed by Lela Clark, seconded by Ken Kruse, the motion to keep Patton on the Council failed by a vote of 4-2, with Kruse and Clark in favor of refusing Patton's resignation, Chapman, Green, Batterbee and Russell opposed.

A subsequent motion to accept his resignation, proposed by Green, seconded by Batterbee, was approved, with Batterbee, Chapman, Green, and Russell in favor, Kruse and Clark opposed.

New Village Council member Bill Chapman, who was appointed two months ago to fill the position vacated by Harry Pletcher, was then appointed President Pro-Tem of the group, also by a vote of 4-2.

Asked if he would accept the position, Chapman inquired as to what would be required of him.

"Nothing, you just have to show up," replied Russell, which drew more catcalls from the audience. After a short explanation of the duties of President Pro-Tem from Clark, Chapman accepted the appointment, saying, "I appreciate the vote of confidence and will try to do my best."
